As you know, the next CMI Conference will be held in Beijing, Peoples Republic of China, from 14 – 19 October 2012. Organisation of the event is now under way and we look forward to another successful conference. The substantive programme will include panels on the Salvage Convention, 1989, and the Recognition of Judicial Sales of Ships as well as the Rotterdam Rules and other highly topical subjects. A tour of the Great Wall of China will be a highlight as well as many cultural tours for accompanying persons. We expect the registration fee to be in the range of EUR 800 – 900. Further, the Organising Committee of the China MLA has agreed to the CMI arranging educational and cultural events in Shanghai from 20 – 22 October 2012. This would be an optional add-on to the conference itself.
